

They range from the brilliant to the out and out frauds. In this section of our guide we have taken 21 of the more well known prostate products along with the best we found and the worst we found to give you an idea of how they rate. These ratings are based on the following criteria: product label, survey results from men taking these products, formula design, and most importantly laboratory analysis of what is REALLY contained in these products.

## **Product** Reviews



**Antiiva** — This is a classic example of a product that is completely worthless and tarnishes the reputation of the entire natural health industry. Sold only through mail-orders by the same group of "weasels" who sell Prosta-8 and Prostend (see attached write ups). They try to trick you into believing this is a legitimate product by using pseudo science, phony testimonials and a "pharmaceutical-sounding" name like Antiiva. It's not. The lab reports expose this fraudulent product for what it is: a rip-off. If you were unfortunate enough to spend money on this "bottle of dirt" you would not have seen any results. Total scam. If you get a letter in the mail from these jokers throw it in the trash!



**Grade C** 

**Better Prostate** — This 17-ingredient product contains very low levels of important compounds. It also contains an herb called "Butchers Broom" which has no scientific studies validating it as being beneficial for prostate health. The lone bright spot in the formula is the 85% to 95% free fatty acid content of the Saw Palmetto used. Unfortunately, it only contains 50mg. Manufactured by Trim International, a company more known for making women's beauty supplements, than men's products. Average lab results, and a \$69 a month price tag don't add up to a winner.



**Grade F** 

**Flotrexx** — A blatant attempt to confuse the consumer into thinking that this is the prescription drug Flomax. Ads for this low-grade product first appeared right as Boehringer Ingelheim Pharmaceuticals, got approval from the FDA to sell Flomax. Lab results actually showed the pill had an above average level of saw palmetto, but not much else. This product is advertised through direct mail. They feature photos of a man identified as Dr. Treadwell Dubois. There is no listing for a Dr. Treadwell Dubois in ANY American Medical Association anywhere in the United States. We believe this doctor is as bogus as this product. Plus, at \$79 a bottle for a one-month supply this is just not worth it.



**Liquid Prostate** - The lone liquid prostate product we have ever encountered. This company specializes in liquid formulas for both humans and pets. While the idea is good – especially for men who do not like to swallow pills, the formula and test results were average. Only 80mg of saw palmetto, and a decent 100mg of pygeum with 13% sterols. Must be refrigerated after first use. Average product but a wise choice if taking pills is a problem for you.

**Grade F** 

**Maximum Prostate** — The owner of the company, John Patrick Acord (aka John Livingston) is a 2 time convicted felon. In 1985 he was sentenced to 10 years in federal prison for securities, wire and mail fraud counts. But enough about their company, let's look at their formula. At one time, their original product "Better Prostate" was actually a decent product . . . until they stiffed the lab for over \$40,000. They were unable to pay their bill because they racked up over \$3 million dollars in legal fees trying to defend themselves in numerous lawsuits, which they ultimately lost. In order for them to stay in business, they had to change the name of both their products and they reformulated it with cheap ingredients. The end result of these shortcuts, as revealed in our survey sheets, was that customers had a very difficult time dealing with this company, and that the pills did not work for them. Lab results were very unimpressive.



**Grade B** 

**Prostate Defense** — North Star Nutritionals of Baltimore produces this well-designed prostate supplement. It's a "soft gel" and the suggested use is four a day. Like all intelligently designed supplements, Prostate Defense contains Pygeum extract yielding 13% sterols and uses an 85% extract of Saw Palmetto. These top quality ingredients were evident in the nice laboratory score this product received. While it was off the mark with Quercetin and Icariin, it is still a better than average product. You can get a bottle of Prostate Defense direct from North Star for under \$50 a bottle.



**Grade B** 

**Prostanol** – This fine "soft gel" product from VitalMax Vitamins was designed by Dr. Al Sears, an advocate for the use of natural health products for men. Dr. Sears does an excellent job designing men's health supplements. Prostanol scored so well in lab reports and got such positive feedback in survey sheets that it made it into the Top 5 comin in at number 5 – not an easy accomplishment! Uses and 85% extract of saw palmetto and had 20mg of beta sitosterol, and provides 266% of the RDA of Zinc. Somewhat Surprising that pygeum is not present in the formula. The proprietary Phytosterol blend of Campsterol, Stigmasterol, Brassicasterol and Sitostanol are effective. The regular price for a one-month supply is \$57.45. Grade B



**Prost-8** — From Hampshire Labs, the Minneapolis based company that specializes in direct mail letters that promise the moon —but deliver poor products. They also make the do-nothing products Prostend and Antiiva. Prost-8 touts itself as the number one product in the world for "optimum prostate health". Strange, since it contains ZERO saw palmetto and ZERO Pygeum, the two absolutely essential compounds for men's prostate health. Outlandish claims and a subpar product is not the combination you are looking for. Laboratory analysis confirms that a purchase of Prost-8 would be a waste of your money.

**Grade F** 

**Prostata** — GeroVita had sold over 4 millions of bottles of this prostate supplement which failed miserably in lab testing. In fact is looks like a classic example of "powder in a bottle" with virtually zero potency! A rip off! Priced under \$40 a bottle it is a complete waste of money based on the independent laboratory analysis. Many survey sheet complained the pills did nothing for them — now we know why. Company founder and creator of this supplement Almon Glen Brasswell gained national attention a few years ago when he, along with financier Marc Rich, were pardoned by President Clinton in the final days of his presidency. Brasswell (who died last year) was a twice-convicted felon, and it looks like he is still ripping people off! GRADE F



**Grade B** 

**Prostate Relief** — This well formulated product contains quality extract concentrations of the key ingredients saw palmetto and pygeum. Other beneficial compounds contained in the formula are Beta Carotene, Zinc, Selenium, Parsley juice powder and a variety of herbs which help to cleanse the kidneys and bladder. Prostate Relief is also recommended to be taken along with their product Intestinal Detoxifier which is a specific formula for Prostatitis, and this herbal combination functions as a cleanser, detoxifier, and strengthener of the prostate. Formulated by Dino Gugliemelli, founder of Natural Science Laboratories to help men experience a morning bowel movement. The theory is that a morning bowel movement assists the body in eliminating toxins being cleaned from the prostate. Nice product that is just a few steps away for being one of the super elite. Good lab scores.



**Prost-RX** – From the highly regarded Atlanta-based supplement manufacturer Hi-Tech Pharmaceuticals, come this exceptional product. We have it rated the number 3 prostate pill due to its exceptional formula and high level of ingredients. While many products are essentially one-dimensional (e.g.: all saw palmetto, or all beta-sitosterol) Prost Rx got high marks across the board. Only a few steps behind Prostavar and Vasotrexx, it is clearly the best of the rest. Many survey sheets remarked how well Prosta Rx has worked and how it is more effective than Flomaxx and Avadart. Super product developed by master nutraceutical formulator Jared Wheat. Grade A -

**Grade C** 

**ProsTec** — This companies advertising promises much more than what the product actually delivers. This very simple 7-ingredient formula uses ZERO extracts, and consists mostly of powders. The ideal form of these natural compounds would be "extracts" NOT powders. The lab report results for Pros Tec were poor. It is distributed by Health Advantage of Carmel, NY . These hard tablets seem very over-priced for the benefits they would deliver. Men who have commented about this product in survey sheets were not very impressed. Their other prostate product T-Pros Ultra also performed poorly. These products are sold over the very "medical-sounding" website — www.healthmd.com, yet the actual benefits you would get using this pills, will be far less than you imagine.



**Grade C** 

**Prosvent**— Maybe you have seen the half-hour television infomercial for this product featuring UCLA educated physician Dr. Larry May. The show or commercials does a terrific job of explaining how important it is for men to be proactive in caring for their prostate in order to eliminate or at least minimize future problems, and offering help in the form of the Prostavent pills to men currently suffering. The formula contains all the key ingredients: saw palmetto, pygeum, Vitamin D&E, Zinc, Selenium and Pumpkin Seed Oil as well as lycopene. Laboratory tests score was only average. Nowhere near the high scores of Prostavar or some of the other super elite products, but certainly decent enough to help some men with mild prostate enlargement. Only complaint about Prosvent is that it costs \$79 a bottle. The high price might be necessary because of the high cost of purchasing the TV infomercial spots. Bottom line is this is a decent product. Grade C



**Grade A+** 

**Prostavar** — Out of all the products we have evaluated, this was the clear choice as the premier prostate product on the market today. Manufactured by Superbalife International, it produced laboratory results that practically made our eyes pop out! Across the board it performed at the highest level. The company attributes the success and effectiveness (of what they call their new and strongest-ever version of Prosostavar) to a processing technique called "Supercritical Extraction." This technique delivers a superior quality extract that is highly concentrated with incredible purity. This is very difficult to do with some of the natural compounds in Prostavar because of their "gummy" texture which makes it difficult and extremely time consuming to produce, but the results and craftmanship speak for themselves (See their attached lab report). The most impressive piece of data we found was that the total number of Sterols in each dose is 159mg. No other product came close. In our nationwide survey it was identified in overwhelming fashion as the most popular prostate pill. We were flooded with jaw-dropping

stories from men and their wives praising how much Prostavar has changed their lives. This product is the Tiger Woods or Mickey Mantle of prostate pills, and we want to congratulate Superbalife International for having created Prostavar, our clear choice as 2010 PRODUCT OF THE YEAR!

**Grade C-**

**Provelex Plus** – The suggested daily dosage is to take 3 tablets twice a day – that's six pills a day. They give you 180 tablets and it appears to be a marketing gimmick. One sign, right off the bat, that this product will come up short is the 50mg's of Pygeum per three tablets are from a powder NOT an extract. It came as no surprise to us when the laboratory analysis revealed below average test scores. Manufactured by Merazon Health Products of Seattle, who received a serious FDA Citation in February 2005 from Office Director Joseph R. Baca for their product Immune Guard after making false claims about its ability to cure the common cold and flu. They were also the subject of an expose on Quackwatch an organization that monitors the natural health industry. Provelex Plus seems like another over-hyped product.



**Grade D** 

**Prulato** – The man who created this product is currently serving 25 years in federal prison for claims he made about the product Enzyte- a pill that – get this – is supposed to make a mans penis longer! Needless to say, it came as no surprise that Prulato does not live up to its claims and promises. While the packaging and promotions for this product might be the fanciest of any product we have seen – it is completely worthless. All that matters to us and YOU are lab reports and feedback from "real men" using the product. In the case of Prulato the lab results were poor and as for testimonials from men – we couldn't find any! At \$59.95 a month it's too high for something of this quality.



**Grade F** 

The Prostate Formula from Real Health Laboratories — The laboratory analysis for this product is here in the book for you to see and the results are shockingly poor! We tested three separate batches and all three individual results concurred that the product contained ZERO active ingredients in any of the major categories. That's ZERO. You can walk into just about any major drug store chain and find this well packaged, attractive, seemingly high quality product from this San Diego based company which boasts that it is "Doctor Developed and Trusted since 1994". The box also has a logo that states "Laboratory Quality Tested" in big letters right on the front — you never really know until you test it. You can't hide in the lab. The label states that it contains "powders" and not "extracts" — and the results speak for themselves. Many men have written stating that they tried this product and were very disappointed having seen virtually zero results.



**Royal Forte Prostate** — These pills finish in the middle of the pack as a result of their formulation and due to the results of the laboratory tests. Developed by Wonder Laboratories of White House, TN, these capsules do not contain the highest grade ingredients. Example: the Saw Palmetto extract yields between 44% to 55% sterols. Compare that with the 85% you find in top shelf products. The Pygeum used is a powdered bark NOT an extract. Has nice levels of vitamins D3 and E, as well as Zinc and copper. A one-month supply is under \$50. At the end of the day this product is average. Grade C

**Grade C** 

**Schiff Prostate Health** — This is a low-priced product from one of the oldest supplement companies in the country. It is a "staple item" in virtually every drugstore in America — too bad it tested so poorly. See the lab report in our lab results section. With a one month supply selling for under \$19 it is virtually impossible for their product to contain high levels of the ingredients that really work! This product is like going to McDonald's - cheap and easy to get but not the most nutritious. For example, the product contains 42mg of free fatty acids, compare that to the 286mg of free fatty acids recorded by Solaray Pygeum & Saw Palmetto and it's not impressive.



**Grade B** 

**Solaray Pygeum & Saw Palmetto** – Solaray began manufacturing and selling herbal products in 1973, originally as a pioneer in formulating and marketing blended herbal products that contain two or more herbs with complementary effects. This product utilizes pygeum bark extract and wild saw palmetto berry that provide the European recommended consumption levels. This formula is complemented with zinc, vitamin B-6, pumpkin seed and amino acids. In the laboratory, it performed well posting a total Free Fatty Acid score of 286mg. The lab analysis is contained in the guide. Out of all the big name companies (those with a product line of more than 50 products) Solaray scored the best. While this is a good product, it is still several levels away from the super elite products. While it had two good scores the product is not as comprehensive as it needs to be to provide fast relief. Great company, good product.



**Grade C-**

**Super Prostate Formula** — This fine product has been on the market for a number of years and has generated luke-warm survey responses. Some men swear by it while many others say it did not help them at all. Looking at the formula and lab reports is clear that it has an impressive amount of sterols and free fatty acids in it. Overall it is too one-dimensional since other key ingredients are not present. It is very similar to Super Beta Prostate, however Super Beta Prostate has higher levels of sterols and free fatty acids. Dr. Michael Telitsky is the doctor who stars in this company's infomercial, and does a nice job explaining why prostate supplementation is important. Good solid product that can help you.



**Grade B** 

**Super Beta Prostate** — The heavily advertised product from New Vitality of New York is one of the better products we have tested! It made it to our prestigious Top 5, finishing at number 4, because of its extremely high levels of sterols and free fatty acids. Designed by chemist Roger Mason, SBP, contains 1,040mg per serving of total sterols and 46mg of free fatty acids. While these levels are both extremely high, it almost seems like over kill. It would have been better if these levels where lower and they included other important compounds as well. Many survey sheets said this formula did not work for them. This is most likely attributed to the fact that not all men have the same prostate problems and while sterols and free fatty acids are certainly important – other compounds are also important. Still, an excellent product from a fine company.



**Grade F** 

**Urinozinc Prostate Wellness** – This prostate formula from the Vitanery company out of Miami, is widely distributed in most major chain store pharmacies. Their box claims it to be a "patented formula" and a silver emblem proudly blares "Formulated by Doctors." Well the doctors must have been drunk when they formulated this because the laboratory report, shows that is contains Zero Free Fatty Acids, Zero Sterols, ZERO Icariin, and ZERO Quercetin and only 1mg total Pholyphenolics. (see attached lab report). This is practically criminal! Imagine if you have been spending your money on this product thinking it is helping you and now thanks to unbiased lab reports, you can see that this product is a rip-off! Compare this score to those of Prostavar, or Prost Rx or Solaray's prostate product and it's comical, like comparing a bicycle to a Rolls Royce. Very disappointing.



**Grade A** 

**Vasotrexx** — Our choice as the number two prostate pill in the land! Dartford Kent Nutraceuticals has produced a distinctive blue tablet formula that is chock full the key ingredients necessary to shrink an enlarged prostate and reduce pain. Survey sheet comments were kind as well. While its laboratory scores were not as strong as those of the top-rated Prostavar, they are better than all others we have tested. High marks for Free Fatty Acids, Quercetin, and over 100mg of total sterols! The only draw back here for some men is the high price they charge. A one-month supply of a 60-pill bottle is \$89 a month. The company likes to say they are the Rolls Royce of prostate pills. At that price they are correct. Though no one likes to put a price on health, and some would pay almost anything to be able to sleep through the night, \$89 does seem to be a steep price for all those not on the Forbes 400. Despite the high price and aura of arrogance from the company, their product is excellent and can help men shrink their prostate and relieve other prostate problems as well. GRADE A

# Steps To A Heal

Pretend for a moment that you lived in an ideal world where you had all the time and money you needed to take care of your prostate. What would your game plan look like? Most of us don't live in that world, so using our best Bill Walsh, Bill Belichick and Tom Landry gameplan we have laid out our 7-point strategy that science and researchers indicate might be the best way to make your prostate bullet-proof. For lifelong prostate health, this simple strategy should be your best offense and defense!

**Eat Healthy – Fruits, Vegetables, Fish, ... And Avoid Fatty Foods** 

A diet high in fruits and vegetables has been linked to a lower risk of all kinds of cancer. Research is cloudy as to why or how compounds in fruit and vegetables may help, but prostate cancer rates are highest in countries where diets have high saturated fat content. So dont stop eating fruits and vegetables! The fresher the better. Eat foods rich in omega-3 fatty acids such as mackerel, herring and salmon (basically any oily fish). Research suggests that diets rich in omega-3s lower the risks of all types

## **Exercise Daily**

Go for a walk and get out and do something. Don't be a couch potato! And don't get heavy. Overweight men have a 25% greater chance of developing prostate cancer. There may be no current evidence that links exercise with a lower risk of prostate cancer. But there is evidence that links exercise to better prostate health. Prostate cancer has been tied to obesity possibly because cancerous prostate cells are fueled particularly well by fat. Exercise improves overall physical and mental well-being. So many doctors endorse getting at LEAST 30 minutes of exercise per week. Other doctors advise you to do what feels good for

your body. So if you need to exercise more, then exercise more. Studies indicate that regular exercise increases the flow of oxygen to the soft tissues of the body and helps to stabilize glucose levels in the bloodstream. For high glucose levels may fuel prostate cancer cells, much in the same way that fat cells seem to.

## **Have 35-50g of Soy Protein Every Day**



Have 35-50g of soy protein every day. Study after study seems to show that diet is one of the major factors in relation with prostate cancer. Prostate cancer incidences and mortality rates in Asian countries are much lower than in the United States. And research suggests that one reason for this may be the high soy content in the Asian diet. In a study published in October of 2004 by the Urological Sciences Research Foundation stated that when Japanese men move to the United States and adopt a Western lifestyle, their cancer rates sky-rocket. According to many published journals, including the International Journal of Cancer, regular consumption of soyprotein-containing foods and beverages may reduce the risk of prostate cancer in men by as much as 30 percent. Bottom line: soy is great for your prostate, eat it in bulk!

## **Visit your Doctor Regularly & Know The Facts**

No one wants to go see a doctor, especially for a prostate exam! Senator Bob Dole summed it up recently. Located in Salt Lake City, Utah, San Rafael Chemical Services (SRCS) was established in 1993 under the direction of Ralph Meibos, a 25-year veteran of chromatographic and spectrometric analysis and interpretation. SRCS specializes in HPLC analysis of biological material. For instrumentation, SRCS utilizes Hewlett Packard's 1090 series II/L HPLC and ties into the HP 5989 A - Mass Spectrometer engine when analyzing certain compounds and for method development. They also have the HP 5890 series II Gas Chromatograph for GC/MS determinations, along with other devices. SRCS also provides microbiological services and has licenses from the State of Utah and the United States Department of Justice, and the Drug Enforcement Administration for controlled substances (1-5) Analytical Laboratory. Professional associations include the American Chemical Society (ACS), the American Society for Mass Spectrometry (ASMS) and the Association of Official Analytical Chemists (AOAC).

San Rafael is one of the few labs that utilizes the high-pressure liquid chromatograph (HPLC) method. All studies performed on the effectiveness of saw palmetto extract utilized an extract with these four major constituents. When purchasing saw palmetto, look for these components. Saw palmetto extract reduces the amount of dihydrotestosterone (DHT) in prostate tissue, inhibits the binding of DHT to androgen receptors in prostate cells, and exhibits anti-estrogenic action in prostate tissue. 


## **Pygeum Africanum Extract**

Pygeum Africanum Extract has demonstrated to be even more effective in maintaining a healthy prostate, with over 70% of patients experiencing a reduction in the prostate size. Pygeum is an evergreen tree found in the mountains of Central and Southern Africa. Its bark, once used as a tea for relief of urinary disorders, has been found to contain not one, but three types of compounds that combat the symptoms of prostate enlargement (benign prostatic hyperplasia). Beta-sitosterol, the most important of the three, interferes with the formation of prostaglandins that cause inflammation and swelling in the

### **Muira Puama Extract**

Muira Puama Extract is also very beneficial for BPH because of its active constituents, which are long-chain fatty acids, sterols, coumarin, alkaloids, and essentials oils. Muria puama extract has a long reputation as a tonic and aphrodisiac, but only recently has its benefits to prostate health come into focus.

## **Beta-Sitosterol is the Most Significant Discovery in Prostate Health!**

Beta-sitosterol has a number of properties that make it uniquely suitable for improving the health of the prostate gland. Some studies have indicated that beta-sitosterol alone may be helpful in combating prostate problems. Beta-sitosterol inhibits the action of the enzyme 5-alpha-reductase, which converts testosterone to DHT. DHT is one of the main contributing factors to BPH. The prostate of an older man has four times the DHT concentration than that of a younger man. In addition, beta-sitosterol also inhibits the enzyme aromatase, which facilitates the production of estra-diol. Estradil levels invariably increase with age. This is considered to be another important factor in the development of BPH. Several studies have proven the benefits of beta-sitosterol on prostate health. The Journal of the American Medical Association published a review of 31 years worth of studies, including 18 different international trials involving 2,939 men. The evidence suggested that standardized amounts of beta-sitosterol and saw palmetto extracts "improve urological symptoms and flow measures." All studies suggest beta-sitosterol is a very useful tool in the treatment of BPH. Stinging nettle extracts are proven to work synergistically with saw palmetto extract in the treatment of BPH.

Supplementation and absorption are paramount for an effective BPH Treatment plan. Zinc has been shown to reduce the size of the prostate and to diminish symptoms in the majority of patients. Amino acids in certain combinations have also proven effective in relieving BPH symptoms. In the majority of users, the combination of the amino acids: glycine, alanine, and glutamic acid have been shown to relieve symptoms, such as feelings of a full bladder. Quercetin is a very powerful antioxidant that has been proven to help BPH. This also holds true for saw palmetto extract and pygeum extract. Quercetin also relieves pain and other symptoms in men with prostate problems. Preliminary reports indicate quercetin may inhibit growth of the cells that damage the prostate. Soy isoflavones are associated with lowering the risk of prostate cancer. Much of this protection is due to the isoflavanoids genistein and daidszein, the phytoestrogens of soy. Obviously, this action has many benefits in the treatment of BPH. Pumpkin seed extract is less effective than other phytopharmaceuticals for relieving symptoms of BPH, but can be used synergistically in a formula for prostate health.



**Q:** I see in the Prostavar lab report it has 28mg of quercetin, and none of the other products have any. What is quercetin and why do you test for it?

**A:** Quercetin may be the strongest of nature s anti-inflammatory substances. Numerous studies have shown it effective in treating a wide range of prostate related problems. A recently published study demonstrates quercetin provides long-term relief with zero side effects. Men suffering from an enlarged prostate find the swelling will go down much faster with high levels of quercetin. Undoubtedly, it is one of the key reasons Prostavar is so effective. We test for it because so many men get up multiple times at night to urinate. Quercetin can help stop this. **Q:** I get up every night at least five times. It has gotten so bad my wife and I don't sleep in the same room anymore. Avodart didn't do anything for me. analysis of this product shows that it is quite deficient in the key areas most important to men's prostate health (see the lab report of the Schiff product in this guide). Just because something is low-priced doesn t mean it is a good deal. What good does it do you to pay \$10 for something that doesn t work? You II still be in pain, you II still be getting up at night and looking for bathrooms all day long. But if you paid \$50 and got a product that really worked for you and your prostate problems vanished, sure you are \$40 lighter in the wallet. But your problem is solved! So save money somewhere else. Don t sit in the cheap seats when it comes to your prostate. It is too darn important!



Q: The lab reports you have done are fantastic and opened my eyes. I must say I am a little disappointed that my local health food store hasn t done this. Why don t health food stores conduct lab tests on their products?

**A:** The answer is simple – money! It costs a lot of money to do High Performance Liquid Chromatography/Mass Spectrometry testing on multiple compounds in each product like we have done. It would cost a health food storeowner half a million dollars to conduct this kind of testing on all the products on his shelves.

**A:** Don't even think of spending 1 penny on any Internet pharmacy. They are all crooked! Not some are crooked. They are all crooked! It is illegal to sell prescription drugs over the Internet for sale into America. Plus, these pills are cheap, they don't contain what they are supposed to contain, and are in fact extremely dangerous! It is like playing Russian Roulette. The operators of these cites are outlaws and could care less about quality control. They get cheap pharmaceutical knockoffs from India and China. We have heard horror stories that resulted in serious consequences for men taking some pills. Over a dozen men we have heard about actually died as a direct result of illegally obtained prescription drugs. Try a good natural supplement first, and you won't even be thinking about these Internet pharmacies.



## Questions & Answers

Q: What is Genistin? I heard it is a pill I should take but my pharmacist never heard of it?

**A:** Genistin is not a pill. It is an isoflavone found in soy protein. In Japan the daily intake of soy protein is far greater than in America and Western Europe, and the incidents of prostate and colon cancers in Japan are far less. Numerous studies suggest soy protein consumption is very important for prostate health. We agree, and rate taking 35-50mg of soy protein a day as one of the 7 Steps to a Healthy Prostate. Many famous men take soy protein every day. Remember Joe Torre when he was with the Yankees and had prostate problems? He spoke about his daily soy protein shake.



Q: I am 77 years old and don't know what to make of my PSA score. What do you think about the importance of a PSA test?

**A:** Men age 75 and older should not be screened for prostate cancer. And younger men should discuss the benefits and harms of the prostate-specific antigen (PSA) test with their clinicians before being tested, according to a new recommendation from the U.S. Preventive Services Task Force. The recommendation and accompanying evidence summary appear in the August 5, 2009 issue of the Annals of Internal Medicine.

The Task Force found evidence that screening for prostate cancer provided few health benefits, but led to substantial physical harms and some psychological harms in men age 75 and older. In men younger than 75, the Task Force concluded that current evidence is insufficient to assess the balance of benefits and harms of prostate cancer screening. An estimated 278,890 U.S. men were diagnosed with prostate cancer in 2007, and one in six men will be diagnosed in his lifetime.



**Q:** I don't have much money to spend on prostate pills. I want to use natural pills rather than prescription drugs that I know have killed a few of my friends. How can I do this?

**A:** Your best bet is to get on a monthly program. Some companies offer to send you a new supply every month at a discounted rate. Or buy a large supply at once. If you buy a 6- or 12-month supply from a company, you will get a deep discount because you are buying multiple bottles. Plus, you only pay shipping and handling costs one time rather than each time you order.

**Q:** I heard that several natural pills have been taken off the market because they were laced with dangerous drugs and, in some



instances, have actually killed some men. Can you tell me which products these were?

**A:** There have been numerous reports like this. First Internet Pharmacies selling prescription drugs should not be taken. They are very dangerous and there have been numerous reports of deaths related to these. On the natural front, the FDA took the herbal pill PC Specs off the market, because it was secretly laced with a prescription drug that could be deadly. Also, there have been numerous recalls by the FDA of herbal sex pills that have been secretly laced with dangerous chemicals and drugs. The products are: Zencore Tabs, Rize2, Aspire 36, and Blue Steel. We have reports of many men being rushed to the hospital after taking these illegal and extremely dangerous pills. Be careful because some of the rouge operators are still selling these pills despite the FDA recall. And these pills could literally kill you.

**Q:** What about sexual dysfunction and the prostate. Is there any correlation between the two?

**A:** Yes, absolutely. The incidence of sexual dysfunction in patients suffering from Benign Prostatic Hyperplasia (BPH), or enlarged prostate, is nearly twice as high as treating physicians believe. This was shown in a new survey from the American Foundation for Urologic Diseases (AFUD) presented recently at the American Urological Association annual meeting.

Lower urinary tract symptoms related to an enlarged prostate are also strongly correlated to sexual problems, including Erectile Dysfunction (ED) and Ejaculatory Dysfunction (EjD). In fact, lower urinary tract symptoms are a risk factor for ED independent of other conditions associated with ED, such as diabetes, hypertension, cardiac disease and hyperlipidemia.

Men with severe urinary symptoms report 50% less sexual activity and 33% reduction in overall sexual satisfaction compared to men without severe lower urinary tract symptoms. "We've seen in our practices that the majority of men over age 50 consider an active sex life important," says Dr. Seftel. "Since men with BPH symptoms are already at risk for compromised sexual function, it makes sense to consider sexual side effects

when treating urinary symptoms of BPH," he added.

**Q:** One of the things that scare me about taking prescription Flomax are the side effects. The one that causes the most concern is the side effect listed as abnormal ejaculation. What exactly does abnormal ejaculation mean?

**A:** There are over a dozen side effects associated with taking Flomax, but the most common side effect is abnormal ejaculation, which occurs in almost 20% of all men who take it. Abnormal ejaculation is a term used to describe several problems with ejaculation. These problems can include: Not
