

REASON FOR MEMORANDUM: 1203.4 P.C. (DISMISSAL)

On April 1, 2003, JOSHUA WILLIAM FOSTER was granted 3 years informal probation after a conviction for violation of Section 23152(a) of the California Vehicle Code. The period of probation expired on March 31, 2006.

The Court suspended the imposition of Judgment and Sentence with the following special conditions:

- (1) Serve 48 hours in the Sacramento County Jail (Time Served).
- (2) Driver's License Restricted.
- (3) Complete DUI first offender program.
- (4) Pay fines and fees.
- (5) Obey all laws.

Restitution is not an issue. Fines and fees are paid in full (3/22/04).

On 11/11/05, the defendant was arrested in Sacramento County for 23152(a) of the California Vehicle Code. On 7/14/06, the defendant was subsequently granted 3 years informal probation following a conviction for violation of section 23103.5 of the California Vehicle Code. (Docket #05T05281)

The defendant is not now serving a sentence for any offense, on probation for any other offense, or charged with the commission of any offense.

This defendant did not satisfactorily meet the conditions of probation during the 3 years of probation status, as he was convicted of a new offense during his probationary period.

In view of his conduct while on probation, it is respectfully recommended that the requested 1203.4 P.C. of the State of California be denied.

REASON FOR MEMORANDUM: 1203.4 P.C. (DISMISSAL)

On April 17, 1998, JOSHUA WILLIAM FOSTER was convicted of violation of section 148.9(a) of the California Penal Code in Sacramento County. He was not placed on probation.

The Court suspended the imposition of Judgment and Sentence with the following special conditions:

- (1) Serve 10 days in the Sacramento County Jail (Time Served).
- (2) Pay fines and fees.
- (3) Obey all laws.

Restitution is not an issue. Fines and fees are paid in full (9/28/98).

On 6/22/98, the defendant was granted 3 years probation in Sacramento County following a conviction for violation of section 496(a) of the California Penal Code (Docket #98F05015). This grant of probation was terminated early on 8/26/98.

The defendant is not now serving a sentence for any offense, on probation for any other offense, or charged with the commission of any offense.

In view of his conviction within one year of being granted probation, it is respectfully recommended that the requested 1203.4 P.C. of the State of California be denied.
